Fees and Rates First Established April 8th 1995, (past increases; January 1, 2000, April 1, 2004 & January 1, 2010). Current increase applies to new Enrollments. This increase will affect current Subscribers as of January 1, 2019.

PINAL COUNTY Schedule of Service Charges Effective June 1, 2018

The following rates shall be charged for annual membership services. Memberships (Subscriptions) for properties/locations outside of City Limits and within unincorporated Pinal County. These rates are based upon under-roof square footage and shall include all buildings, living areas, basements, garages, storage buildings and barns or outbuildings on the premises. Contiguous unimproved land up to five (5) acres included at no additional charge.

1. SINGLE FAMILY RESIDENTIAL PROPERTY:

(Includes Manufactured Homes 1980 and newer)

2. MOBILE HOMES (Residential Use 1979 and older):

3. COMMERCIAL (BUSINESS) PROPERTY:

First 1,000 Sq. Ft.	\$450.00
1001 – 50,000	\$450.00 + \$.14 psf.
50,001 – 100,000	\$450.00 + \$.11 psf.
Over 100,000	\$450.00 + \$.950 psf.

Fire-Safety Discounts available for locations which have;

- A. Property Equipped with a central station, monitored Fire Detection System
.....-10%
- B. Property equipped with an (approved) Automatic Fire Sprinkler System
.....-20%

4. UNIMPROVED LAND:

- A. \$150.00 for the first acre or portion thereof.
- B. \$15.00 per contiguous acre, after the first acre.

5. EACH MEMBERSHIP shall be subject to a registration fee of \$30.00. Re-enrollment of all cancelled or expired memberships that have lapsed by reason of non-payment for a period of 30 days after the expiration date shall be subject to the \$30.00 re-enrollment fee upon written notice of cancellation to the member by Regional Fire & Rescue Department.

6. NON-EMERGENCY SERVICES:

RFRD provides non-emergency services to our Subscribers as a courtesy, when available, and are at no additional charge to a Subscriber. These include Home or Vehicle Lockout Services, Poisonous Reptile or suspected Africanized Bee Removals, Blood Pressure Checks or Medical Assessments to include First Aid, Lift Assists, Smoke Detector Assistance (Battery or detector replacement with customer provided detectors or batteries) assistance with Carbon Monoxide Detectors, and response to troubleshoot chirping smoke detectors/alarms, etc.

7. NON-SUBSCRIBER FEES-FOR-SERVICES:

Response to non-subscribers for vehicle collisions, fires or for similar emergency services requests shall be chargeable at the fee-for-service hourly rates.

- A. Each Emergency Apparatus chargeable at **\$750.00 per hour**
- B. Emergency Personnel utilized at a scene are **\$75.00 per hour**
- C. Medical or Rescue Calls for service via 9-1-1 will result in a **\$435.00 minimum** charge for every response from Basic Life Support (EMT) personnel.
- D. Advanced Life Support services from an I-EMT or Paramedic are charged **\$495.00**. The rates in C. and D. includes additional personnel riding in assistance on the Ambulance to the Hospital.
